The applicant agrees that this application is subject to the Board's Rules and Regulations, a copy of which is open for inspection at the Board's office. These Rules and Regulations are incorporated as terms of this agreement.

The Board shall have the right, but shall not be obligated, to inspect any installation before electric, water and/or wastewater service is introduced, or at any later time, and reserves the right to reject any wiring or appliances, not per Board standards. Such inspection or failure to inspect or reject shall not render the Board liable or responsible for any loss or damage resulting from defects in the installation, wiring, or appliances or from accidents that may occur upon the premises receiving service.

If a customer determines that the premises to receive service has not been connected to the available wastewater system, the Board will waive the connection fee upon request to connect to the system. All customers are charged the wastewater fee based on reasonable access whether or not said premises are connected to the wastewater system. The Customer's responsibility is to determine if the premises receiving service is connected to the wastewater system.
